ORDER

No. SEC/2E-II/2021/ 651 :-Whereas, Smt. Ramesh Devi had contested election from Ward No. 19, Zila Parishad Bhiwani held on 17.01.2016. She was disqualified by the State Election Commission vide order dated 12.12.2019 due to non submission of election expenditure statement within the prescribed time limit.

2. Whereas, Smt. Ramesh Devi has filed a representation against the above referred order. She has stated that due to domestic work and her bad health, she was not able to submit the expenditure statement. She has submitted her election expenditure statement in original alongwith affidavit. She prayed for withdrawal of disqualification order referred above.

3. I have examined the expenditure statement filed by Smt. Ramesh Devi which is within the expenditure limit prescribed by the State Election Commission, Haryana vide its order No. SEC/2E-II/2015/5782 dated 03.06.2015. So far as filing the election expenditure within prescribed time limit is concerned, I have gone through her representation and office record carefully. Taking a lenient view in the matter, I hereby order to remove her disqualification and also withdraw her name from the list of disqualified candidates issued vide order dated 12.12.2019.

4. I further direct that a copy of this order be sent to the candidate concerned through Deputy Commissioner-cum-District Election Officer, Bhiwani.

5. I further direct that a copy of this order be hosted on website of the Commission www.secharyana.gov.in.
