4. You have already been declared Drawing and Disbursing Officer for operating the expenditure Head of the State Election Commission, Haryana and

presenting the requisite bills in the Treasury for drawing and disbursing the necessary payment.

3. The details of expenditure incurred out of the allotted funds may be supplied to the Commission in Form B.M 26 and B.M.29 by the 10<sup>th</sup> of the following month.

4. The amount allotted may be drawn from the treasury against the expenditure bills only.

5. It may be ensured that the all bills are checked by S.O.s and supported by the duty programme and duty certificates signed by the Competent authority (ies).

6. The bills should be passed at the level of the Deputy Commissioner only and properly entered in the Expenditure Register. The remuneration of employees deployed on election duty, may be incurred as per instructions issued by Commission in yellow booklet circulated vide No. SEC/3-Account/2010/ 408-428, dated 29-03-2010 and other instructions issued from time to time.

7. The expenditure incurred will be debitible under head "2015-Election-101-Election Commission-02-Charges for the conduct of election for Panchayat (Non Plan) (Object Head 68 -Election Expenses) during the financial year 2010-2011.
